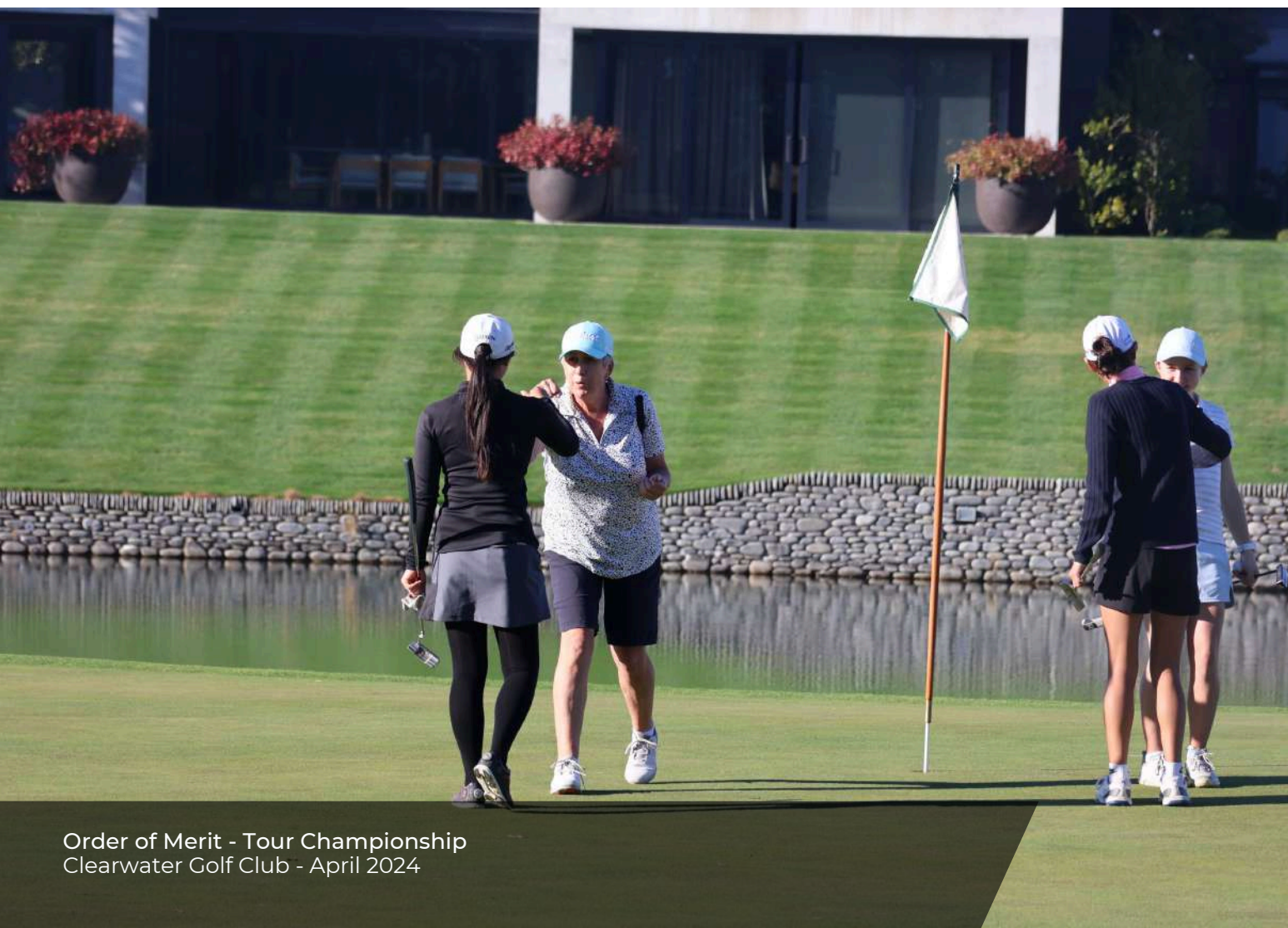

Measuring Our Progress

Canterbury Golf has three key strategic drivers for 2021-2026 to support the golf clubs in Canterbury and the development and future of the amateur game. The following outcomes have been achieved over the past 12 months. The new five year strategic plan was published late 2021.

CLUB SUPPORT

- 3.1% increase in club membership for the year to 30 June 2024.
- Regularly sharing of organisation operations and progress via sharing of monthly Executive Committee minutes
- Regular engagement with local representatives of the General Managers Association sharing insights around management of the game within clubs
- Continued research into potential Golf NZ partnership agreement and consultation around this with clubs in lead up to and at 2023 AGM
- Increased number of clubs visited in person by Canterbury Golf representatives in the last 12 months.
- Profile & Perception- Golf in Canterbury profile continues to rise with 19.8% increased reach via Facebook and 18.6% increased reach via Instagram.

PARTICIPATION

- 6.4% increase in rounds played across Canterbury Clubs for the year to 30 June 2024
- 12.3% increase in Junior Boys membership over the last 12 months.
- 60 Futures Hub & Girls Golf coaching programmes delivered over the last 12 months with 413 junior players taking part.
- 10 Futures Canterbury Hub events delivered.
- 16 Junior events delivered including Junior Opens, Age Group Championships, and Secondary School Championship
- 12 She Loves Golf events delivered.

COMPETITION GOLF

- 23 Interclub competitions delivered with 1450+ players involved.
- 30 tournaments delivered with 1500+ players involved.
- Canterbury teams competed in 12 representative events within the season across all genders and age groups, with 146 Rep player selections with our teams bringing home 2 South Island titles (Men's Masters & Women's) and 1 National title (Girls Interprovincial.)
- Continuation of CGI Talent Development programme with 26 players involved. Further enhanced our reputation as one of the leading golf TDP systems in NZ.
- Delivered a South Island Development Camp to develop the next tier of aspiring youth players.
- Canterbury TDP members Seb May (17 years of age) wins 2023 NZ Amateur Championship and Cooper Moore selected to join the Golf NZ National Academy.
- Introduction of Development Fund prizes as part of the 23/24 Order of Merit

General Manager's Report

The 2023/24 year has again been a largely positive one for all in our game as I reflect back proudly on my first 12 months in the General Manager role with Canterbury Golf.

Regional Snapshot

As a region, the game of golf continues to track positively both in terms of memberships in clubs, people playing the game and the ever increasing investment into golf participation facilities. This year for the first time Canterbury Golf club memberships collectively broke the 14,000 mark, with the number eventually sitting at 13,921 as at 30 June, representing another 3.1% increase in membership from the previous 12-months. Rounds played too continues to track positively with close to 605,000 rounds played across Canterbury Clubs with the large majority of clubs seeing increased numbers. These positive trends also correspond with increased investment in golf as witnessed with the completion of the long-term Sir Bob Charles Golf Centre project being completed and opening in June providing further opportunity for engagement with our game and ultimately we hope leading to more participation in our clubs either through membership or through casual participation.

Leadership & Finance

As an organisation we had one significant change at the top with existing Canterbury Golf President Michael Rondel gaining appointment to the Golf NZ board in December and subsequently stepping aside from the role of Canterbury Golf President, fortunately for us however agreeing to stay on the Executive. I would like to pass on my sincere thanks to Mike for his assistance to myself in the GM role which was invaluable. As a result, Mike was then fittingly replaced as President by his Vice President at the time, Dion Kerr who has taken to the role impressively containing a strong desire to continue to drive Canterbury Golf forward. In respect to the organisation financial performance in the 23/24 year, pleasingly through a combination of operation efficiencies and the valuable work of the Finance Committee, we managed to work to budget and even perform better than expected seeing us return a modest surplus for the year.

Participation & Talent Development

We continue to see positive trends both in terms of adult engagement and young people across the region. After consultation with participants some small changes were implemented for our popular showpiece event, the Canterbury Stroke Play. With this year's event held at Christchurch Golf Club an increased playing field of 108 players was accepted which required a tough ballot process to whittle the entries down from the over 170 received to the eventual 108 featuring many of the best amateurs across the country. The event included Open Men's & Women's categories allowing u19s, seniors, and master's players a like chance to lift the premier trophy, while still maintaining trophies and accolades for their respective age categories alongside this. This player consultation also led to the Canterbury Match Play returning to a 3-day event with initial qualifying rounds followed by rounds of 16 and so on. This new format meant a change to the tournament date with this set to take place over Labour Weekend.

In the interest of wanting to increase the incentive for local players to play in the various OOM events throughout the season, as well as create another avenue to help players development, Canterbury Golf this year introduced Development Fund prizes for the CGI Tour. The intention of these Development Funds while to help grow playing numbers at the various OOM events run by clubs and CGI is also to assist aspiring local players in their development. The funds are able to be spent on accessing developmental support or towards golf event travel and entry to enable them to play more competitive events.

Interclub action continues to be as popular as ever with clubs looking to enter more teams than in the past. This led to the creation of a new premier interclub competition in 2023 with the creation of the Thompson/MacDonald trophy, named after recent CGI Life Membership recipients John Thompson and Peter MacDonald. This competition effectively created a fourth tier of the men's premier interclub pyramid which added to the number of clubs, teams and participants that

were able to take part. This inclusion also added to an already highly competitive and anticipated interclub Finals Day which was fiercely contested at Pegasus last November. In all we now deliver 23 different Interclub competitions which cater to all age groups and genders and has close to 1500 members participating from 35 different golf clubs.

Junior Golf also continues to prosper with an increase of 10% in junior members over the last 12 months, which has coincided with numerous record registrations for some events such as the 103 golfers who registered for the Secondary Schools Championship. The Futures Canterbury Hubs continue to offer new golfers an affordable and attractive initial step into the game which resulted in 285 new futures sign up's over the last 12 months. With our continued focus on supporting the transition of these members into clubs, we hope to see the long-term effects of this programme in the future. As well as our delivery of group coaching programmes and beginner-friendly hub playing events, we also have a strong emphasis on helping these members learn and understand golf etiquette and respect as part of their inductions and have also introduced Futures themed pitch repair tools in the welcome packs. While Futures represents one end of the Junior pathway continuum, our Talent Development Programme represents the other. We have continued to invest and deliver this programme with 26 of our most promising Boys & Girls taking part in monthly sessions where we intend to aid their development both on and off the course to holistically develop these young people, both as players and people within our Canterbury Golf community. Sessions this year have included the players formally sitting a Level 1 Canterbury Referees' exam as well as engaging with former Canterbury leading amateur and now professional Kazuma Kobori. I am particularly proud of this programme which is recognised as one of, if not the best regional association Talent Development Programme in NZ.

Representative Golf & Individual Player Success

It was another huge year for Canterbury Rep golf with our players taking part in 12 total events, 7 of which took place in the North Island. Our most notable performance was from our Canterbury Girls team who took out the NZ Girls Interprovincial trophy for the first time since 2014, an impressive achievement. In terms of South Island honours our men's Masters team took home the trophy alongside our Women's team with their victories at Ashburton and Rangiora Golf Clubs respectively. Our Men's team came agonisingly short of making the final at the NZ Interprovincial eventually losing their semi-final in a second play-off hole, highlighting this game of inches. Excitingly however the Men's & Women's NZ Interprovincial tournament is this year returning to Christchurch with the event set to be played at Russley and Harewood Golf Clubs in December, I look forward to seeing many members of the Canterbury golfing public out in support of our teams on home soil. In terms of individual honours, a mention of course is required for two of our TDP members, Seb May who won the 2023 NZ Amateur Championship as well as Cooper Moore who was selected to join the Golf NZ National Academy. A mention too for Kazuma Kobori who ended his long run of Canterbury representation after turning professional in November.

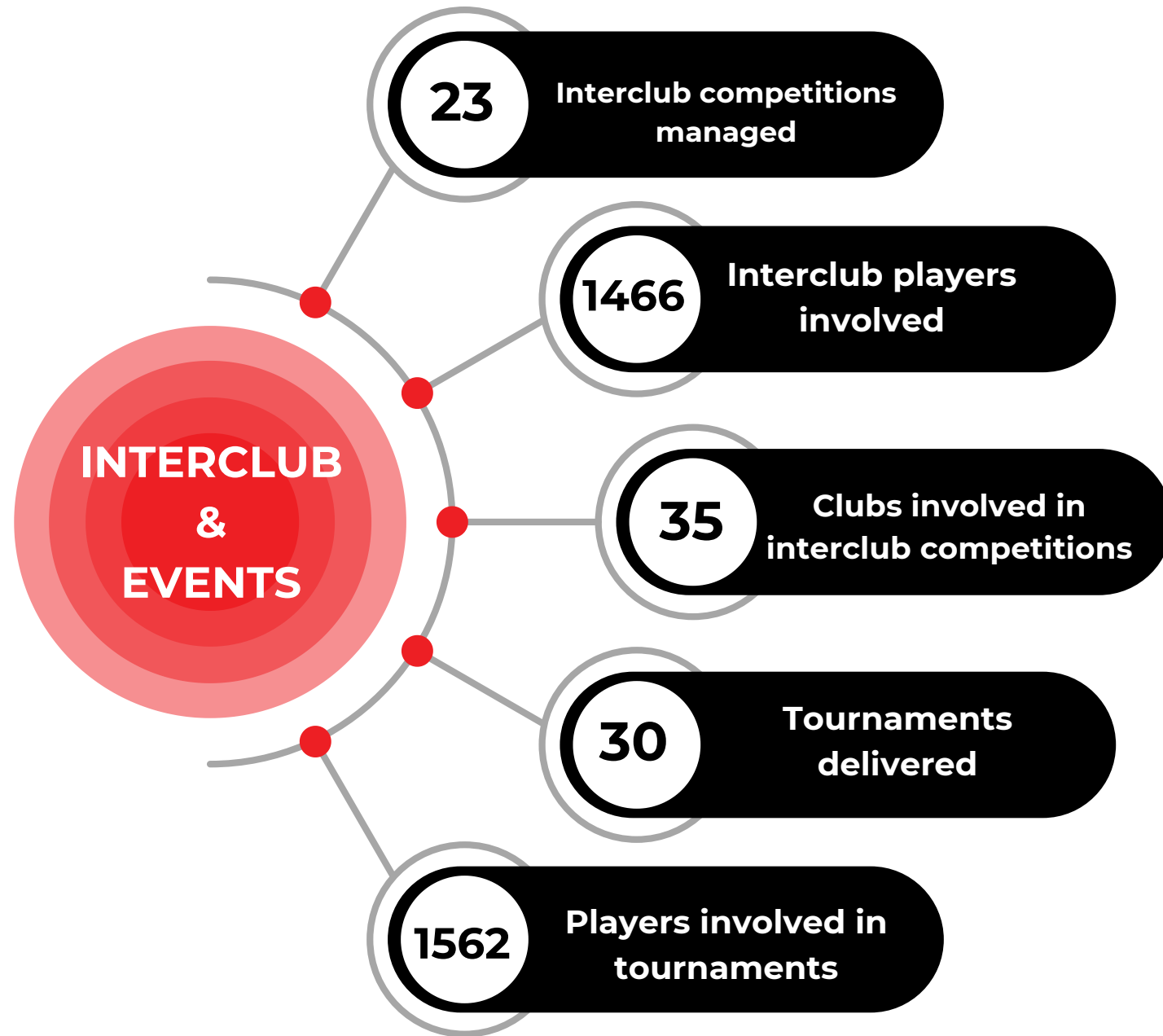
Looking Forward

I know another year has flown by when I'm in the midst of reviewing our Canterbury Golf Draft Events Calendar for 2025, and the start of Woodward, Blank, Simon, Pollock Cups, and our newest Men's interclub competition Thompson MacDonal Trophy are just a matter of weeks away.

Last year's interclub programme was completed without too many dramas or weather postponements, which was a pleasant surprise, as finding alternative dates is always challenging in the current golfing climate with the popularity of our great game showing no signs of slowing down.

Our interclub competitions and events continue to be very well supported with 263 teams and just under 1500 competitors involved in our 22 interclub competitions over the past 12 months, while our tournaments in general are fully subscribed and our premier events regularly requiring ballots. Another very positive trend is the number of talented junior golfers competing at our Canterbury Junior Opens each month, with a record 78 entries at our Avondale event just last month.

The condition of our Canterbury courses continues to be a credit to our hard-working greenkeepers, committees and army of volunteers in particular, who unselfishly give their time so that the majority of us can enjoy great playing conditions when we get the opportunity. You all perform a wonderful service to the golfing community and we in turn must ensure that we respect your hard work by replacing divots, carrying sand buckets and repairing not just our own but any pitch marks we notice on our greens.

Everything I've mentioned earlier doesn't just happen by chance. Our club administrators and professionals, convenors, rules officials, coaches and participation coordinators lay the groundwork to ensure this success, and you all should be proud of the work you do, often unseen in trying conditions.

Our Presidents', Secretaries' and Captains' Day at Harewood Golf Club this year was again a great success with 92 competitors from 22 clubs supporting the event. Harewood's hospitality and catering added to the great atmosphere on the day for all those who attended. Next February's event will be hosted by Clearwater Golf Club, being current Canterbury Golf President Dion Kerr's home club, so make a note in your social calendar now.

Food for thought ... the difference between a good round and a great round, is attention to detail.

Reflecting on the past 12 months has been truly rewarding. It's impressive to see how much we've accomplished and achieved in the region during this time. The significant growth in participation is notable across our events and memberships.

It's been an enjoyable year watching the development of our young golfers in both competitive and non-competitive environments, and to see the passion they have for this game. We currently have 382 members within our Futures Canterbury membership. Over the past year, 266 new members have joined up across both our Selwyn and North East hubs. The number of young people getting into golf is outstanding and extremely important as they represent the next generation and the future of golf.

Each school term, we offered between 12 to 16 Learn & Play Programmes. During the winter months the programmes are reduced due to limited daylight but in Summer & Spring these programmes become very popular, attracting over 90 kids. These programmes would not be possible without our dedicated coaches, Andy Sams, Jordan Pruden, Matt McLean and Jess Reid. These coaches do a tremendous job in delivering these sessions each week and I can't thank them enough for their ongoing support, encouragement and patience with our young kids.

Our futures hub events have been a real hit for those new to golf or simply wanting to give it a try. The feedback we receive from the kids and families has been very positive, which provides us with valuable insights and helps us understand what we are trying to achieve with our young people.

A couple of highlights from the year include our Secondary Schools Championship event, held at McLeans Island Golf Club earlier in the year. The event reached a record number of 103 players from 25 different schools and 28 teams. Additionally, our Canterbury Junior Open held at Avondale Golf Club set a record of 78 players for a Junior Open. These achievements are outstanding.

The She Loves Golf series remains a highlight, it's impressive to see the engagement and enthusiasm we have for each of the events. It's exciting to see women, whether new to the game or with minimal experience, courageously taking on the challenge of golf. They have a lot of enjoyment and the support from golf clubs and volunteers makes these events so successful.



I would like to thank all the golf clubs who host our events throughout the year. These events would not have gone ahead without access to your courses, we greatly value the support you give us.

A special thank you also goes out to the participating clubs in the North East and Selwyn Hub for your invaluable support in the Futures Canterbury programme. We appreciate the engagement, communication and support from the clubs that play a significant role in nurturing the future of the game.

Representative

Its mandate is to see that the policies of selection, procedures and communications channels required by Canterbury Golf are adhered to. Representative fixtures are played across a wide spectrum of Canterbury Golf including Senior Men and Women, Masters Men and Women and Junior Boys and Girls. Selection processes are rigorous with selectors taking into account individual performances across Interclub competition, open tournaments both local and nationwide, events involving players competing overseas as well as previous results players have achieved in representative play for the province. This ensures that all players have many opportunities to press their case for representative honours. Pre-season meetings involving the various selection panels and potential representatives are held and this gives the panels the opportunity to set in place the programme for the year and for the players to be aware of the selectors expectations of them.

The Representative season got underway with the annual fixture against neighbours Aorangi. The Senior men, women and junior were comfortable winners whilst the Masters mens suffered a narrow loss. 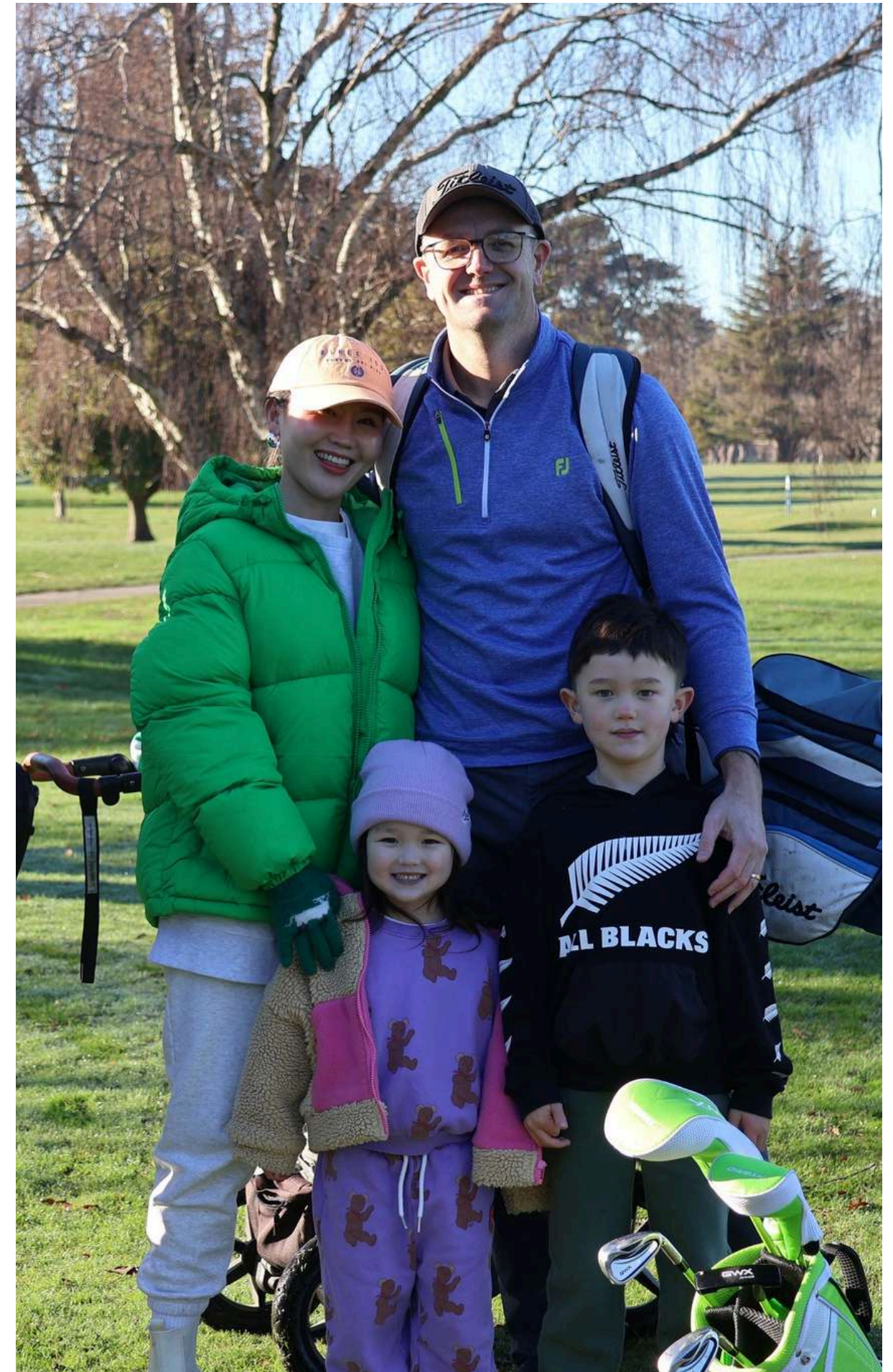

Main Sources of Canterbury Golf's Cash and Resources

Canterbury Golf's activities are funded by member levies, grants, sponsorship, donations, interest, and activities that attract a user-pays contribution.

Main Methods Used to Raise Funds

Each year affiliate clubs are levied based on the number of individual members they have. This accounts for about 63% of Canterbury Golf's income. The remaining funds come from service delivery (22%), sponsorship (8%) and funds received from across national body, grants and other sources (8%).

Reliance on Volunteers and Donated Goods or Services

Canterbury Golf relies on gifts of volunteer time and expertise to complete work in many essential governance and operational roles. Under the Executive Committee it operates 13 sub-committees all manned by volunteers.

Description of Canterbury Golf's Outcomes

Based on its 2021-2026 Strategic Plan, Canterbury Golf aims to deliver outcomes based on an Annual Management Plan that provided KPI's toward the achievement of the 2026 strategic goals targeted at club support, participation, and competition golf.

Club Support – supporting clubs to ensure they are sustainable, increasing memberships, and performing well for their members.

Participation – increasing both membership and the number of overall rounds played.

Competition Golf – facilitating and improving competitive golf including high performance programmes, increasing the number of Canterbury players selected for national representation, and a competitive interclub competition.

Achievement of these outcomes enables golf to improve its service and contribution to the well-being of the Canterbury community as a sport, pastime, and recreation.

Club Support and Sustainability

Canterbury Golf has worked closely with Golf New Zealand, and the respective Canterbury based General Managers Association representatives. Together we have provided support and guidance to individual Clubs in the region on an as-needs basis.

Participation

We have continued to deliver our Canterbury Golf Young People in Golf Development Plan focussed on improving service to young people, increasing participation, and fostering talented young golfers. This has continued in conjunction with our Futures Canterbury programme delivery for young people and families as well as our Girls Golf and "She Loves Golf" campaigns and additional community focussed introductory golf events such as Golf in Schools programme delivery and SNAG Inflatable Driving Range activations.

Statement of Accounting Policies:

Measurement Base:

The accounting principles recognised as appropriate for the measurement and reporting of earnings and financial position on an accrual basis are followed by the organisation.

The financial statements are prepared on the assumption that Canterbury Golf Incorporated (CGI) is a going concern.

The financial statements have been prepared in accordance with PBE SFR-A (NFP) Public Benefit Entity Simple Format Reporting which CGI is eligible to apply since its operating expenditure is less than \$5,000,000 annually.

Specific Accounting Policies:

The following specific accounting policies which materially affect the measurement of profit and financial position have been applied:

Revenue

Grants and Donations

Donations are treated as income upon receipt. Grants received conditional on expenditure for specific purposes are treated as liabilities until spent. Upon expenditure on the intended purposes grants are recognised as income.

Levies

Club levies are invoiced based on the calendar year, unpaid invoices are recognised in sundry debtors. At 30 June 2024 50% of the annual levies are recognised as income in advance.

Depreciation

Depreciation has been calculated using rates applicable to write assets off over their expected useful lives.

Goods & Services Tax

The society is registered and the financial statements have been prepared on a GST exclusive basis except for Accounts Payable and Accounts Receivable which are stated inclusive of GST.

Fixed Assets

Fixed Assets are recorded at cost or revaluation less accumulated depreciation.



Revaluation of Assets

Land and buildings were last revalued based on the Christchurch City Council Valuation Notice of 1 August 2022.

Income Tax

The organisation promotes amateur sports and has a general exemption from taxation (s.CW 39).

Liabilities

Liabilities are stated at the estimated amounts payable and include obligations which can be reliably estimated.

Income in Advance

At balance date levies of \$165,442 (2023:\$153,913) invoiced prior to 30 June 2024 were carried forward to the next financial year.

Contingent Assets and Liabilities

There were no contingent assets or liabilities as at 30 June 2024 (2023: Nil).

Changes in Accounting Policies

There have been no changes in accounting policies. Some comparative numbers have been restated to better align with current financial reporting structures.

Vehicle Lease Commitment

At balance date Canterbury Golf Incorporated leased two vehicles from VFL Flexilease and the outstanding commitment under the lease agreements for the three vehicles totaled \$0 (2023: \$14,433) as the current leases have expired at 30 June 2024 and the vehicle leases are now operated on a month by month basis.
